



Spring 2020 Course Evaluations

Howard University

At Howard University, The Office of Institutional Research and Assessment (IRA) conducted course evaluations for 11 colleges and schools. Evaluations were made available to students on April 13, 2020 and closed April 28, 2020. Faculty received course evaluations on May 11, 2020.

For Howard University:

2176 courses received at least one evaluation
42354 evaluations were sent
14998 evaluations were completed (response rate of **35.41%**)

A total of 21 questions (8 course, 11 instructor, and 2 COVID-19) were asked across all departments.

In the tables below, both a general mean and a course mean are supplied. The general mean aggregates all student responses (as though the department was one class). This mean is useful when understanding the general student experience across the evaluated courses. The course mean is an “average of averages” and treats each course mean as a data point. The course mean is useful in understanding faculty performance regardless of class size.
