| March 25, 2022 | Communication regarding the Graduating Student Exit Survey will be sent to Deans and Chairs with language that can be sent to students, |
| | Deans and Chairs should forward reminders on to their students to maximize response rate. |
| March 29, 2022 | Communication regarding course evaluations will be sent to Deans, Chairs, faculty, and students. |
| | Final instructor or course adjustments will made as necessary. |
| April 1, 2022 | Graduating Student Exit Survey and Alumni survey are opened. |

| April 5, 2022 | Course evaluations are opened. OUC communication about course evaluations and GSES will be sent. |

| May 16, 2022 | Course evaluation reports are available to instructors. * |
| May 31, 2022 | Howard Annual Assessment Reports due for all academic units (results and actions). These should be submitted directly into the Planning and Self-Study System. |

| | Chairs should submit these directly into the Planning and Self-Study System. |
| June 15, 2022 | IR Academic Profiles made available to all academic units. |
| June 30, 2022 | Provost Annual Reports are due for all academic units (results and actions). |
