HAAP is the process Howard uses to assess academic and administrative units for continuous improvement.

HAAP is centered around a basic assessment process that includes creating outcomes, identifying measures to assess those outcomes, implementing your plan, reporting the results from implementation, and including tangible action items to start the cycle for the next academic year.

Tips for Completing the HAAP

- Align your outcomes and measures with your unit's strategic plan
- 2. Think of innovative ways to improve your current operations
- 3. Collaborate with other units for peer review
- 4. Review the IRA resources online
- 5. Connect with the Assessment team for assistance
